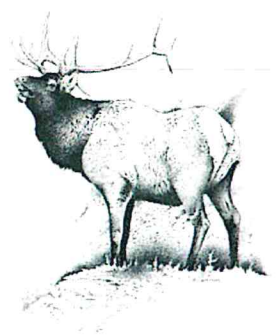

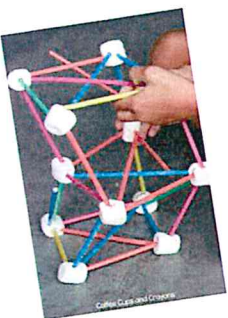
You're invited to join the Pojoaque Valley School District's Before and After School (B&A) / Summer Education and Recreation Program focused on exercising your brain and body!

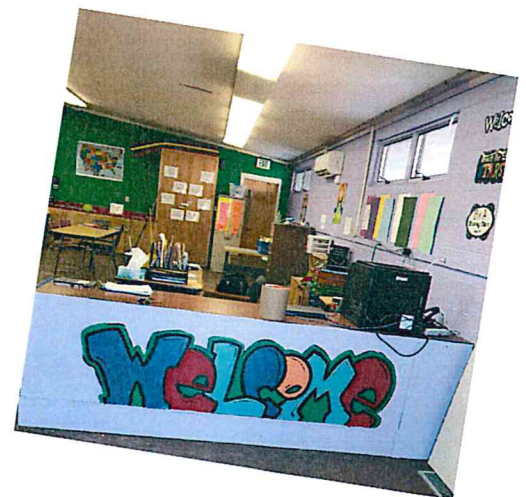
A healthy Breakfast, Lunch and Afternoon Snack will be provided to every participant.
